Shalom Center for Conflict Resolution and Reconciliation Training for the Prevention of Election Violence in Kenya

On February 12th, SCCRR were invited by the Officer Commanding Police Division of Nakuru to facilitate a training of police officers to enhance their skills in Conflict Management in light of the upcoming elections. In the aftermath of the 2007 elections, Nakuru experienced violence between different ethnic communities, leaving many people injured, displaced and

extensive damage to personal property. From the experience of the last elections in Nakuru, the police officers identified their fears for the upcoming elections and reflected on the causes of election violence. They highlighted their fears regarding the possible loss of property, displacement of persons,



sexual violence and a delay in the election results. Further concerns expressed were how rumours, hate speech, rigging and failure of the political system were causes which might lead to election violence. The group of police men and women, emphasized the possibility of being misused by those in positions of authority, putting them in a compromising position. As part of the SCCRR workshop, the participants from Nakuru Police Division drew up an action plan based on the workshop presentations pertaining to the paradigms of conflict theory and conflict transformation. They pledged themselves to embrace dialogue and negotiations amongst themselves and the public and to provide adequate security to the public during the election period.

SCCRR WORKSHOP IN THIKA

A UNITED PEACEFUL KENYA - NOW AND THERE AFTER

The Catholic Justice and Peace commissioners drawn from the 12 deaneries in the Archdiocese of Nairobi congregated at the Thika Pastoral Centre with mixed expectations. some were tired after the daylong party nominations held country wide, but they had something to smile about - someone had remembered them very early in the year.

Early Saturday morning after an encouraging homily from Fr Emmanuel Ngugi, the CJPC chaplain, members met in the main hall waiting to get more from this fountain of knowledge. Fr. Emmanuel introduced to us to Fr .Patrick Devine, like everyone else, I had not met him before .He was full of zeal (from my quick assessment), he talked to us with humor like he had always known us. In the same strength he introduced his organization and his powerful team of facilitators.

The key area of concern was the Enhancement of Analytical Skills on the Prevention of Election Violence and Interventions Promoting Peace in Kenya as we move to the Kenyan Election in March 4th. During the day we discussed the fears we have and the causes of election violence in Kenya which were very much rooted from the personal experience of people in the aftermath of the 2007 election.

At the close of day, it was on every members lips, how the interactive seminar had reignited the flames of effective endeavor to work among and between the Kenyan communities on the need 'to be their brother's keeper'. This was evident in the deanery work plans they made before leaving the venue.

I am convinced that the seminar equipped the commissioners with the necessary knowledge, skills and attitudes to handle the task at hand. This is so because the facilitators enabled people of different levels of cognitive abilities to grasp and internalize the concepts. The Archdiocese of Nairobi now has a rich and vibrant resource base to work with, in close consultation and guidance from Fr Patrick and his team. The inter-deanery networks that were established will also apply the social teachings of the church and ensure that Kenyans of all socio-cultural-political and religious affiliations become team players in rebuilding what we (as onlookers, perpetrators and victims) destroyed for selfish reasons in 2007/08.

May the entire citizenry of this republic of Kenya also re-think and re-define which shape Kenya will take,

as they now have another opportunity to exercise their democratic right (voting in credible leaders).

My hope and prayer is that they will do it 'with a renewed heart and renewed spirit'
